
By the same *token*, the world is facing a growing need to tear down borders, in search of a complete social and financial inclusion.

# **Exchanges, Use, and Security**

# **Types of Crypto Assets**

Criptocurrencies can be divided into categories based on how they are intended to be used and their ability to solve real-world problems. Our goal is to work with you on creating a diversified portfolio that focuses on some of the most promising projects with the highest ROI. Some of these categories are:



**Payments. -** These are crypto assets that can be regarded as digital money, operated by a distributed network of computers utilizing blockchain software. In some cases the idea is to complete with fiat money, in other cases, replacing the old legacy payments and remitances systems.



Infrastructure - A few projects are looking to create platforms in which other cripto assets can be created and developed. Such is the case of Ethereum, Solana, Polkadot, and others. Ethereum gave birth to decentralized applications or dapps, which are disrupting the finance (DeFi), arts, gaming, and technology sectors.



**Financial -** There are also projects that facilitate the exchange and trading of assets. Such is the case of decentralized exchanges and swaps like dydx, uniswap, sushiswap, and others. More complex projects include market making, lending, and ways of connecting new projects with investors



Service - Service cryptocurrencies usually offer a variety of tools for the management of personal or enterprise data on the blockchain. Some service crypto assets work to provide its users with digital identities and the ability to link individual's records from the real world to the blockchain.

Media and Entertainment - These are projects that helped integrate the use and distribution of tokens into games, social networks, internet browsers, etc. The idea behind them is usually to reward users for created content, levels achieved in a game, betting, etc. They have also proven to be successful in financing games, events, and virtual worlds.

Store of Value - Despite their volatility, Bitcoin and a few other assets can be considered some of the most important stores of value in the crypto space, due to its limited supply and lack of manipulation from central banks.

# **Profit from your Assets**

Once you are in possession of your crypto assets, there are many strategies you can adopt to profit from them. Here are a few ways of maximizing your ROI

**HODL -** A term used in crypto which means to hold your assets. Long-term holding has historically been a good strategy for good crypto projects that have utility and good potential

**Staking** - It refers to the act of putting up collateral to serve as proof of a user's willingness to participate in the project and assume risk. Their financial interest in the continued success of the protocol being supported is an indicator of the staker's actions being in good faith to the network. Some protocols natively require staking for proving a user's participation and financial functions, while others use staking as a way of drying up circulating supply to pump the price.

**Yield Farming** - While somewhat similar in nature to staking, yield farming refers more exclusively to providing liquidity to a DeFi protocol pool in return for yield. Farmers are those who actively seek out the highest yield on their assets, rotating between pools to maximize their returns.

**Liquidity Mining -** This is a subset of yield farming described above. The main difference is that liquidity providers are rewarded not just with fee revenue but also the liquidity platform's native token.
